12. Clerk's Report/Open Spaces Report.

The Clerk reported that since the last meeting she had still not received the quote for tree works, therefore the planned publicity had not yet been actioned for a Diamond Jubilee Planting Scheme. There were some complaints still about the quality of the goal mouth areas on the adult pitches and this was being closely monitored. Two more complaints had been made by a neighbour about noise disturbance on parish land and this was being investigated, with replies requested by 7th November to both these and a further complaint. It was difficult to prevent all issues like this and a verbal apology had already been given. The new security gate was being installed the following week which should help. The RoSPA report on the playground inspection would be circulated for the December meeting. Outstanding tasks and ground work from the July inspection report by members were being allocated to Wardens. Inspection of the war memorial was also still to be arranged.
