

Final External Auditor Report and Certificate 2017/18 in respect of Castle Bromwich Parish Council WA0050

Respective responsibilities of the body and the auditor

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with Proper Practices which:

External auditor report 2017/18

On 28 September 2018 we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2018. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review.

The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report the internal auditor has ticked 'Not Applicable' to Box F which suggest the council do not hold any petty cash. However from the bank reconciliation we can see that the council do hold petty cash. Please make sure all assertions in the internal audit report are covered and answered correctly.

The smaller authority has not provided:

- year end bank statements to support the bank reconciliation to Section 2, Box 8. These were requested as part of our intermediate review procedures.
